OLYMPIC CHAMPIONSHIP GOLF.

Arthur Havemeyer the Only New Yorker Left in the Tournament.

ST. LOUIS, Mo., Sept. 20.—As the result of the first round of match play in the Olympic international golf championship at the Glen Echo Country Club to-day, only sixteen golfers are left to compete in the second round to-morrow. Chicago has six representatives left, of which not more than four can survive, as Ned Sawyer and Simpson Foulis, Wheaton Golf Club mates, and H. C. Egan and Nathaniel F. Moore are drawn as opponents. Arthur Havemeyer of Deal Beach is the only New Yorker left in the running. Frank C. Newton of Seattle, Wash., is the representative of the Pacific Coast, while former Amateur Champion of Canada George Lyon is the sole golfer from a foreign country. St. Louis clubs furnish five survivors.

Most of the thirty-six-hole matches to-day were one-sided, and few surprises developed. A. B. Lambert of the home course found Walter Egan of Exmcor in an erratic meod, and the Chicago-Harvard player succumbed, 7 down. B. P. McKinnie, champion of St. Louis, took victory from Harold Weber of Toledo in the only extrahole match of the day, 1 up in thirty-seven holes.

Arthur Havemeyer won a runaway match from S. T. Price of St. Louis, striking a wenderful streak in the afternoon, while his brother, Raymond, fell an easy victim to Robert E. Hunter, Midlothian Club champion. Champion H. C. Egan won by indifferent golf, plainly showing that he was far from the brilliant form which marked his recent victory at Baltusrol.
